# <u>Clean Energy Program – Stage 1 Application Form</u>

### **1** Eligibility Information

This is an application form for Stage 1 of the Gullen Range Wind Farm Clean Energy Program (CLEP). Stage 1, also called the 'Energy Efficiency Package', is where an Energy Efficiency Expert undertakes an energy audit on your home or business. You must complete Stage 1 of the program before you may apply for Stage 2.

Before you spend time filling out this form, you should first confirm that you meet the following eligibility criteria:

- 1. You are the owner or tenant of a residential or commercial building located within 5 kilometres of any wind turbine on the Wind Farm.
- 2. You are not receiving a payment from the Wind Farm for a lease or easement relating to the wind farm.
- 3. You are not the tenant of somebody who is receiving a payment from the Wind Farm for a lease or easement relating to the wind farm.
- That the residential or commercial building that is the subject of this application was granted DA approval on or before December 23<sup>rd</sup> 2014.
- 5. That the building subject to the application is constructed (or in the final stages of construction) and in regular use.

You will then be eligible to apply for Stage 2 of the program.
