## **Clean Energy Program – Stage 2 Application Form**

### **1 Eligibility Information**

This is an application form for Stage 2 of the Gullen Range Wind Farm Clean Energy Program (CLEP). Stage 2 of the Clean Energy Program is split into Stage 2A and Stage 2B. Applicants must choose between either Stage 2A or Stage 2B on this application form.

Under Stage 2A (Solar Reimbursement Package), residents may apply to install a solar hot water service, a solar PV system or a battery storage system. Note that funding will not be awarded for the maintenance of existing installations.

Under Stage 2B (Home Energy Efficiency Improvement Package), residents may apply for funding for works that will materially improve energy efficiency for a house or business, such as insulation, double glazing, or other similar improvements. The primary purpose of the proposed improvement must be to materially improve energy efficiency. Applicants must be able to describe how this is to be achieved in their application.

You must complete Stage 1 of the program before you apply for Stage 2. You cannot currently apply for Stage 2 if you have already received a Stage 2 grant.

As part of filling out this form, you will be required to obtain two quotations for the works you are applying for funding for. Section 6 of this form includes requirements for the quotations you obtain. Please read this before obtaining your quotations.

### **2 What happens after you have filled out this form?**

If your application is approved, you will receive a letter from us including a copy of our Funding Agreement. You must sign and date the agreement and post it back to us. We will then countersign it and post you a copy. Once you have received the countersigned agreement you may engage your supplier.

If your application is to be waitlisted or is considered not valid, we will also contact you.

The information provided above is a summary of how the CLEP works, provided for your convenience. Further summary information is provided in the Clean Energy Program brochure, the CLEP Guidelines and the Funding Agreement. The program is governed by the Community Enhancement Program, a document available on the Gullen Range Wind Farm website.

## Clean Energy Program – Funding Agreement

Thank you for your Clean Energy Program (CLEP) application to install a [solar hot water service/solar PV system/insert others]. ### 1 Introduction

### 2 Payment

- (a) an initial deposit of 15% before commencement of the works; and
- (b) the balance following completion of the works.

Amounts will be payable to one supplier only, being the supplier approved under this letter agreement.

You will issue NGRWF with a direction to pay in the form set out at Annexure A to this agreement (**Direction to Pay**).

Provided you give us the documentation referred to in paragraph 3 below, NGRWF will pay the Supplier the approved amount under this agreement directly on your behalf by the time required under your payment terms with the Supplier, provided that date is at least 14 calendar days after receipt of a Direction to Pay by NGRWF. NGRWF will not be responsible for incomplete or inaccurate details or any delay by you in issuing a Direction to Pay.

Where the cost of installation exceeds \$[Approved amount to be specified based on approved full or partial funding amount] for any reason, we will not be responsible for that excess and you must make your own arrangements for payment of the balance to the Supplier.



### **3 Documentation**

To receive the Funding, you must provide NGRWF with the following:

- (a) prior to the commencement of installation works by the Supplier:
  - (i) a signed copy of this agreement;
  - (ii) a Direction to Pay an initial deposit of 15% of approved funding;
  - (iii) a copy of the invoice (made out to you) for the value of the deposit of 15%
  - (iv) proof of the Supplier's public liability insurance of at least \$5 million; and
  - (v) copies of the trade licences and CEC solar accreditation (if applicable) held by the Supplier
- (b) following completion of the installation works by the Supplier:
  - (i) a copy of the Supplier's invoice, including the serial number/s for the installed System;
  - (ii) photographs of the installed System, including the serial number/s for the installed System;
  - (iii) copies of any relevant certificates of compliance for the works (for example, a Certificate of Compliance for Electrical Work (CCEW));
  - (iv) a declaration completed by the Supplier in the form set out in Annexure B; and
  - (v) a 'Direction to Pay' the balance of the Funding.

### **4 Works**

The works are to be completed by the Supplier within 180 calendar days from the date of Funding approval. NGRWF will not be responsible for any cost increases by the Supplier for any reason, or invalidity of the Quote. If the works are not completed within this time, NGRWF reserves the right to seek a refund of the deposit from you or from the Supplier named in your initial Direction to Pay.

You are responsible for obtaining all relevant development consents, approvals and permissions required for the installation works, including any landlord consent, local council requirements or strata approvals.

We may request to inspect the works within 14 calendar days of receipt by us of your final Direction to Pay. If this is required, we will contact you to arrange a reasonable time for inspection.

### **5 No Liability or Contract**

The agreement by NGRWF to pay the Supplier does not create a contractual relationship between NGRWF and the Supplier and is not a representation, warranty or guarantee by NGRWF in respect of the Supplier, the System or the installation works.

NGRWF, the Energy Committee and the Energy Efficiency Expert will not be responsible for the performance, malfunction, maintenance or associated property damage of any scheme approved under the CLEP, and do not warrant the performance of any such scheme.
