Independent Assurance Report to the Energy Committee of the Gullen Range Wind Farm Clean Energy Program

Our Opinion

We have undertaken a reasonable assurance engagement on the fund statement of the Gullen Range Wind Farm Clean Energy Program (“the CLEP”) for the year from 23 December 2022 to 22 December 2023 (“the Fund Statement”).

In our opinion, the fund statement prepared by the Energy Committee of the Gullen Range Wind Farm Clean Energy Program (“the Committee”) has:

- a. fairly presented the Fund Statement (being the income, expenditure and balance) of the CLEP for the year from 23 December 2022 to 22 December 2023 as shown in Table 4 contained in section 5.1 in the Annual Report and;
- b. complied, in all material respects, with the requirements of section 5.3 of the Gullen Range Wind Farm Community Enhancement Program Document (version ref: NGRWF_P_003_11).

Basis for Opinion

We conducted our engagement in accordance with Standard on Assurance Engagements *ASAE 3100 Compliance Engagements* issued by the Auditing and Assurance Standards Board.

We believe that the evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Inherent Limitation


